CITY OF SEATTLE
RESOLUTION _____

A RESOLUTION expressing the Seattle City Council's opposition to the current form of Trade Promotion Authority (“Fast Track”), strong concerns about draft elements of the proposed Trans-Pacific Partnership (TPP), and support of fair trade practices and agreements that protect American jobs, protect workers, protect the environment, improve the quality of life in all signatory countries, maintain the integrity and sovereignty of our judicial system, and not give multinational corporations power to undermine national and local governmental authority to create reasonable rules and regulations.

WHEREAS, the City of Seattle strongly supports international fair trade practices and agreements that foster economic growth and high standards for labor, our environment, and public health; and

WHEREAS, Washington is a trade dependent state in which at least 40% of jobs are directly or indirectly related to international trade, and in the last decade Washington exports grew 176 percent, from \$29.6 billion in 2004 to \$81.6 billion in 2013; and

WHEREAS, Seattle is home to the Port of Seattle, the Trade Development Alliance, and scores of internationally-successful companies employing our people and heightening Seattle’s interest in the TPP and Congressional “Fast Track” authority; and

WHEREAS, the TPP will likely involve policy matters related to intellectual property, labor, human rights, agriculture, natural resources, the environment, government procurement, financial services, healthcare, telecommunications, energy, and others, all important to our city, other local jurisdictions, and Washington State; and

WHEREAS, fair trade practices and agreements should promote the creation of family-wage jobs, encourage shared prosperity, protect our environment, ensure the safety of food and other products, revitalize manufacturing, and ensure local governments can regulate for high standards;

WHEREAS, the TPP, like other international trade deals, is being negotiated in closed-door negotiating sessions between the United States and 11 Pacific Rim nations and has not been made available to the public or state and local elected officials; and

43 WHEREAS, in 1999 the Seattle City Council issued a resolution opposing the proposed
44 Multilateral Agreement on Investments, which contained investment provisions
45 similar to those contained in the proposed TPP, as described below; and
46

47 WHEREAS, the January 2015 draft of the Investment Chapter of the TPP includes
48 “Investor-State Dispute Settlement” provisions that could give multinational
49 corporations excessive power to undermine national and local governmental
50 authority to create reasonable rules and regulations, including those related to
51 environmental safeguards, future climate policy, food safety standards, and specific
52 protections for American jobs; and

54 WHEREAS, members of Congress, including Congressman Jim McDermott of Seattle,
55 signed letters in 2012 and 2013, calling on our trade representatives to consult with
56 Congress to pursue a more transparent and inclusive legislative process for
57 consideration of the TPP; and

59 WHEREAS, in a letter dated December 3, 2014, Governor Jay Inslee urged the United
60 States government to take a lead role in establishing trade rules that address
61 emerging issues and challenges in international trade, including foreign restrictions
62 on cross-border data flows, improved protections of intellectual property rights, and
63 improved international regulatory cooperation; and

65 WHEREAS, Governor Inslee also cautioned that in its current form the liabilities of
66 investor-state provisions outweigh their potential value, urging our trade
67 representatives to maintain strong support of protecting state and local regulations
68 over trade rules, with the interest of expanding our state’s leading economic sectors,
69 while including enforceable labor and environmental provisions in trade agreements;

72 WHEREAS, the President has asked Congress to approve the TPP under "Fast Track"
73 procedural rules, which limit our Congressional representatives’ ability to adequately
74 review, debate and amend the TPP and make a determination as to whether the TPP
75 is in the best interests of the American people and our local residents.

77 NOW, THEREFORE,

79 **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEATTLE,**
80 **THAT:**
81

82 Section 1. The Seattle City Council opposes “Fast Track” authority in its current
83 form for the Trans Pacific Partnership (TPP) and, instead, urges the President and
84 Congress to conduct a fully transparent and inclusive legislative process for consideration
85 of the TPP. Further, just as global economics and competitiveness have undergone
86 considerable change, the City Council believes Congress should update the rules and
87 procedures for Trade Promotion Authority so that trade agreement parameters match the

88 complexities of the 21st century economy, and Congress identifies and adopts the
89 parameters through a timely, meaningful and open public process.

90

91 Section 2. The Seattle City Council strongly supports fair trade practices and
92 agreements that protect American jobs, protect workers, protect the environment, include
93 enforceable labor and environmental standards, improve the quality of life in all signatory
94 countries, maintain the integrity and sovereignty of our judicial system, and do not give
95 multinational corporations excessive power to undermine national and local governmental
96 authority to create reasonable rules and regulations.

98 Section 3. The Seattle City Council urges President Obama and U.S. Trade
99 Representative Michael Froman to negotiate a Trans-Pacific Partnership agreement that
100 meets the above principles.

101

102 Section 4. If these principles are not adequately addressed in the final Trans-Pacific
103 Partnership Agreement, the Seattle City Council will urge our Congressional delegation to
104 vote to reject this trade agreement.
